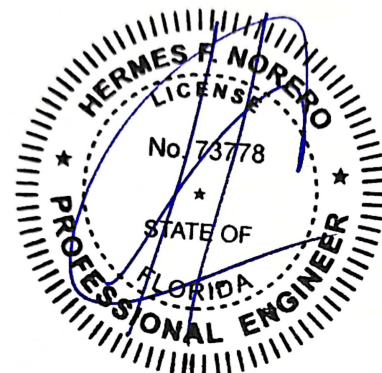

2. Product anchors shall be as listed and spaced as shown on details. Anchor embedment into substrate material shall be beyond wall dressing or stucco.
3. When used in areas requiring wind borne debris protection this product complies with Chapter 16 of the current Florida Building Code and **does require** an impact resistant covering in areas requiring impact resistance.
4. Site conditions that deviate from the details of installation instructions **EWS032** require further engineering analysis by a licensed engineer or registered architect.
5. See Installation Instructions **EWS032** for size and design pressure limitations.
